Our programmes reach over 27,000 young people each year in 11 regions, over 40 communities across Aotearoa.

## Payroll Giving

Payroll Giving allows you to make donations directly from your pay and receive immediate tax credits via PAYE.

If your donation is more than \$5, you receive a third of the donation amount as an immediate tax rebate. For example, if you donate \$30 you'll only have a \$20 reduction on your take home pay. And to top it off there's no need to retain receipts or file an annual donation claim form.

To support the Graeme Dingle Foundation through Payroll Giving, all you need to do is fill in the form on the back and pass it on to your employer.
